Mr. Delgado provided the School Updates

Mr. Delgado said that school will be starting with 510 children. New students coming into 6<sup>th</sup> grade, PreK-3, PreK-4, and kindergarten. There are five new teachers and have kept 20 teachers. Reasons teachers may not be staying: not being certified, a district is taking them and more secure with contract, wanted a position closer to home, or a new promotion.

## 4. Discuss and consider Board minutes from 6/19/18

Ms. Graves wanted to include amendments to the minutes from 6/19/18 to include how Mr. Delgado spoke and met with the moms on several occasions about the rules and the moms said they did. Ms. Graves moved to approve the Board minutes with the amendments from 6/19/18. Ms. Valencia seconded. All were in favor. Motion passed.

#### 5. Discuss and consider EMAT Certification

Mrs. Mukerji informed the board that the certification needed to be signed by the board members and the superintendent every year. It is about using the federal funds to be able to buy instructional materials, but without the signature, she cannot buy anything.

#### 6. Discuss and consider bids for school acoustics

Mr. Sajche discusses the problems (project to small) he faced while trying to find three companies for the acoustics. Mr. Sajche spoke to AECO Interior Contractors and they were too busy until after Labor Day and wanted us to check back after that time. The second company is Ventex, who did send a proposal, but they did not send anyone to come to look at the school yet. The third company, Sheffield Acoustical, the work we need to be done is what they do. The Sheffield Acoustical match the evaluation we already did. The Sheffield Acoustical is the best option as far as someone willing to do the work. Ms. Graves would like to have references from the Sheffield Acoustical company as a tool. Ms. Valencia moved to hire Sheffield Acoustical Company pending on references and reviewed on the Better Business Bureau.

## 7. Financial update as of 6/28/2018

Mr. Tran discussed month ending cash basis of July, it is shy of \$2.9 million. Moving on to the budget, Mr. Tran wanted to point out that many of the expenditures are under budget, but most of the big expenses happen at the end of the year. So come at the end of August, we will have a better understanding of how much money is still left for the year. The topic of expanding and having a second school was also discussed.

## 8. Adjourn

Mr. Velez Moved to adjourn the board meeting. Ms. Valencia Seconded. All were in favor. The meeting was adjourned. Our next meeting is scheduled for Tuesday, September 18, 2018, at 6:30 pm.
