- 551.076 To consider the deployment, or specific occasions for implementation, of security personnel or devices.

- 551.083 For the purpose of considering standards, guidelines, terms or conditions the Board will follow, or instruct its representatives to follow, in consultation with representatives of employee groups in connection with consultation agreements provided for by Section 13.901 of the Texas Education Code.
- 551.084 For the purpose of excluding witness or witnesses from a hearing during examination of another witness.
