The evaluation will identify any barriers preventing parents, particularly those who are economically disadvantaged, disabled, have limited English proficiency, literacy, or are from ethnic or racial minorities, from participating in parental involvement activities. It will also assess the PFE policy's content and effectiveness in improving the academic quality of schools, while meaningfully involving parents. The findings will be used to develop evidence-based strategies for more effective parental involvement and services and to revise the PFE policies if necessary. The district's Campus Needs Assessment process includes a focus group/committee that specifically reviews family and community involvement.</p>

The school district will distribute this policy to all parents of participating Title I, Part A children on September 19, 2025, during the district Open House.




APV Elementary Goals for 2025-2026

 - Teachers will engage students in weekly projects in all subjects to help build relationships while setting high intellectual expectations for their learning.






